Probation & Parole Sweep 'Operation Fallen Leaves' Nets 14 Arrests *One of State's Top Ten Most Wanted Sex Offenders among those arrested*

Members of Dover's Probation & Parole Office were among several law enforcement agencies who conducted a round-up Tuesday that targeted probationers in Kent County who had active warrants from various courts for violation of probation. 'Operation Fallen Leaves' lasted six hours and produced 14 arrests, including one of Delaware's Top Ten Most Wanted Sex Offenders, and two administrative searches.

Assisting in the operation were the Delaware State Police Governor's Task Force, Dover Operation Safe Streets, and Dover Police.

The following nine subjects were arrested on active warrants for Violation of Probation:

Jesus Cintron (02/02/65), Felton. Tier III registered sex offender. Active rule 9 warrant from Kent Superior Court for failure to re-register as a sex offender, and active warrants from Kent Superior Court(x2) including VOP. Committed to DCC on cash bond. *Cintron was listed as one of the Top Ten Most Wanted Sex Offenders in Delaware.*

Richard Curd (01/20/69), Dover. Active warrants from Kent CCP(x2) including VOP, committed to DCC on cash bond.

Brian Tunnell (03/14/71), Dover. Tier II registered sex offender. Active warrant from Milford Police Department for indecent exposure second degree, active warrants from Kent Superior Court(x3) including VOP, active warrants from Kent CCP(x3), also arrested by Dover Police Department for failure to re-register as a sex offender, resisting arrest, and criminal impersonation. Committed to DCC on cash bond.

Zena Chambers (09/12/62), Smyrna. Active warrant from Kent CCP for VOP. Committed to WCI on cash bond.

Paul Derr (04/16/68), Millsboro. Active warrants from Sussex Superior Court for VOP and JP 14. Committed to DCC on cash bond.

Jacqueline Troise (12/09/82), Dover. Active warrants from Kent CCP(x2) including VOP. Released on cash bond.

Tabitha Cuffee (08/28/79), Dover. Active warrants from JP 7, Kent CCP(x4), and Kent Superior Court for VOP. Committed to WCI on cash bond.

Bruce Lane (11/20/85), Dover. An administrative VOP warrant was executed and he was committed to DCC.

David Paitzel (08/18/80), Magnolia. Arrested for offensive touching(x3), criminal mischief, criminal trespass III, and disorderly conduct by Troop 3 uniform patrol. An administrative VOP warrant was executed and he was committed to DCC.
